I grant permission for my child or children (Please Print) _____ to participate in the Miami International Music Academy ~The Academy~, Open Academy & Akademia Programs (hereinafter referred to as "MIMA") during the Academic year in session.

I understand that in order to participate in the program(s), my child (ren) must abide by the established rules and codes of conduct established by MIMA staff. Miami International Music Academy Director, reserves the right to dismiss a child from MIMA due to that child's disruption of the program, including but not limited to tardiness, absence, unpreparedness, verbal and physical aggression against staff or other participants, failure to follow safety or program instructions, and any other disruptive behavior. A child's dismissal will be at the discretion of the Director of MIMA.

I understand and agree to assume any and all risks associated with the MIMA's activities. I grant permission for my child (ren) to participate in classes and activities that are part of the scheduled activities for MIMA. I understand MIMA classes may take place in public and private outreach centers.

I grant permission for my child (ren) to be photographed and recorded for purposes of publicity. I understand that some photographs may appear on the website, local newspapers or future brochures.

If any illness, injury, or accident occurs which, in the sole judgment of the staff of MIMA, requires immediate medical attention, I give consent for any member of the MIMA staff to obtain such emergency treatment. I further consent to the signing of any releases by program staff, which may be required by any medical care provider. I understand that in the event of an emergency medical situation's I will be notified as soon as possible. I also agree to provide the MIMA staff with emergency contact numbers.

I further understand that the cost of any medical care deemed necessary for the treatment of any emergency illness, injury, or accident occurring while my child is attending the Program is my responsibility, and that the Miami International Music Academy's agents and employees are not obligated to pay for such medical care.

For the sole consideration of the Miami International Music Academy allowing my child (ren) to participate in this program, I hereby release and forever discharge MIMA and South Florida Friends of Classical Music, Inc., their members individually and their officers, agents and employees, and the outreach centers, from any and all claims, demands, rights and causes of action of whatever kind that I may have either arising from or by reason of any personal injury or property damage resulting from or in any way connected with my child's participation in this program.

I further covenant and agree that for the consideration stated above I will not sue South Florida Friends of Classical Music, Inc., the Board of Directors, its members individually, its officers, agents, employees or the outreach centers for any claim for damages arising or growing out of my child's voluntary participation in the MIMA program(s).

I understand that the acceptance of this release, waiver of liability and covenant not to sue shall not constitute a waiver, in whole or in part, of sovereign or official immunity by said Board, its members, officers, agents, and employees.
